II. Administrative and University Service Experience

1. Dean, College of Social Sciences & Interdisciplinary Studies, California State University, Sacramento (CSUS). This is the second largest academic unit at CSUS, comprising 10 departments, 4 autonomous programs, 12 centers, a wide variety of bachelor's, masters, and certificate programs, nearly 170 faculty FTE, and 5,400 students choosing programs within the College as their majors. I just took over leading the college and am initiating strategic planning work, expanding the college's global engagement,

expanding the college's collaborations with state government in Sacramento, and working with college faculty and staff to establish a stronger college culture and identity.

2. Founding Dean, School of Public Affairs, St. Cloud State University. St. Cloud State University (SCSU) is the largest institution in the Minnesota State Colleges and Universities (MnSCU) system, the second largest university in the state, and a Masters One regional comprehensive university. The university has an enrollment of approximately 16,500 students and has over 700 full time faculty members. The School of Public Affairs (SoPA) came into existence on July 1, 2011, as part of a major reorganization of the university. The school includes the Departments of Economics, Political Science, Criminal Justice, Geography & Planning, the Social Studies Teaching program, and the newly-formed SOPA Research Institute. The school offers 12 undergraduate degree programs, 5 graduate (Masters-level) degree programs, and an assortment of certificate programs. During the 2013-14 academic year, SoPA had approximately 1,350 undergraduate students and approximately 150 graduate students majoring in its programs. The two largest undergraduate programs are the BA in Criminal Justice (approximately 600 students) and the BA in Social Studies Education (approximately 200 students). The two largest graduate programs are the MA in Criminal Justice and the MS in Public Safety Executive Leadership. The SoPA Research Institute includes the acclaimed SCSU Survey, the Spatial Analysis Research Center, the Center for Economic Education, and the St. Cloud Area Quarterly Business Report.

I was appointed by the Provost to be part of the team that oversaw the transition to the reorganized university and then served as the Founding Dean of SoPA, first as an Interim Dean and now as permanent Dean. I have acquired the skills necessary to manage the transition of an academic unit into a new organizational structure, building the new unit's "brand," and taking responsibility for all aspects of its operations. Below are highlights of my accomplishments as SOPA Transition Leader, Interim Dean, and now Dean:

- (A) From January, 2011 to my appointment as Interim Dean on May 9, 2011, I chaired a task force overseeing the transition to the new school. The workgroup focused on all aspects of the transition from budgeting and HR to program alignment, technology, and faculty evaluation;
- (B) As Interim Dean and permanent Dean, I was responsible for all aspects of the school's operations since May 9, 2011. Below are my major accomplishments and ongoing activities in these assignments:
 - (i) I facilitated the completion of a 5-year strategic plan for the school.
 - (ii) I facilitated work towards completion of an application to the system to offer a Master of Public Administration (MPA) program.
 - (iii) I facilitated the creation and launch of the SOPA Research Institute. The Research Institute is a central coordinating structure within the school that will host a number of active research assets, focus on revitalizing some dormant assets, and invest in new research projects. The Research Institute facilitates faculty and student research, provides expertise and data to the region, generates internal and external funding, and collaborates with other units on campus, other universities, and community partners, on important research projects of a public affairs nature. The Research Institute opened on July 1, 2013, with a primarily dedicated faculty research director and administrative support staff. Very quickly thereafter, the Institute generated nearly \$100,000 in external funding and construction was completed within the university's largest building to locate the

- Institute's offices. This is SCSU's first active research arm and one of very few research arms in the system. SoPARI was featured in a front page article of *The St. Cloud Times* on February 17, 2014 (see http://www.sctimes.com/apps/pbcs.dll/article?AID=2014302170010)
- (iv) I built partnerships between SoPA and overseas universities. Since the school's founding, I travelled five times to China, once to Ghana, and once to South Africa, to visit universities for the purpose of exploring collaborative arrangements with SOPA.
- (v) I hired a complete staff in the dean's office and added to the ranks of permanent and contingent faculty. The positions in the dean's office include an Administrative Director (essentially an Assistant to the Dean), Student Relations Coordinator (the head school advisor) and an Experiential Learning & Outreach Coordinator (who manages internships in the school and works on promotion and marketing of the school to the university community, including alumni). The persons hired into these positions began work in Summer, 2012. Within the faculty ranks, I completed six tenure-track faculty hires (Department of Geography and Planning (Land Surveying & Mapping Sciences and Planning and Community Development programs), Department of Criminal Justice, Department of Political Science, and Department of Economics), twelve Fixed Term faculty hires (Departments of Economics, Geography & Planning, and Criminal Justice), and a large number of adjunct faculty;
- (vi) I started a "SOPA Colloquium Series"
- (vii) I started a "SoPA Newsletter Series"
- (viii) I started a program in the school to reward faculty for meritorious scholarship
- (ix) I developed and implemented a system to provide compensation to faculty for supervising graduate and undergraduate capstone projects that are done outside of teaching load.
- (x) I facilitated the raising of a gift for one program and raised money from alumni, faculty, and staff to support many of activities.
- (xi) I facilitated the securing of institutional approval for SCSU to offer a British Studies Minor and a certificate program in health care administration;
- (xii) I facilitated the process of ABET re-accreditation of the Land Surveying & Mapping Science program;
- (xiii) I facilitated the application and admission of SoPA to be an Associate Member of the National Association of Schools of Public Affairs and Administration (NASPAA).
- (xiv) I facilitated the formation of community outreach projects for SoOPA students and faculty.

(C) Other accomplishments as Interim Dean/Dean:

- 1. I served as administrative co-chair of the University Online Task Force from January, 2012, through May, 2013. The charge of the task force was to make recommendations to the Provost on the strategic direction distance education should take at SCSU and I co-wrote a final report submitted to the Provost in June, 2013;
- 2. I was charged by the President and Provost to facilitate the expansion of the university's engagement in the American Democracy Project (ADP);

- 3. I served on a university-wide search committee, as the representative from Academic Affairs Council, to hire a CIO. The CIO search was completed with a successful hire in December, 2012;
- 4. I served on a university-wide task force to promote wellness at the university.

II. I was appointed by the SCSU administration to administer this department for the duration of the 2010/11 academic year, as a result of the sudden and unexpected resignation of the chair. My responsibilities were to ensure that day-to-day department operations functioned smoothly, a class schedule for the 2011/12 academic year got written in a timely fashion, order be restored to the department following a period of controversy and upheaval, and the drafting of a department handbook documenting all practices, rules and procedures necessary to ensure efficient and effective departmental operations in the future.

Founder and Director of M.S. in Applied Economics program at St. Cloud State University, 1995-2001, 2005-06; I led a faculty effort that to start up a graduate program in Applied Economics, which was approved by the State of Minnesota for implementation in Fall Quarter, 1995. I wrote the application and testified on it in St. Paul and worked with administrators and Economics faculty at SCSU on all aspects of the program's start-up. I started up and led the department's graduate studies committee, which works with the director to administer the program. As director, I handled all aspects of the program's administration, including recruiting new students through campus visits throughout the region. I also led a faculty effort that led to approval of the department's "3+2" program, where students can complete BA and MS degrees in 5 years. I wrote the initial proposal and worked with SCSU administrators to obtain state approval of the 3+2 program in Summer, 1999. The 3+2 program was launched in Fall Semester, 1999.
